Surgical Fires...Recommendations to Reduce Surgical Fires and Related Patient Injury

The FDA is reminding health care professionals and health care facility staff of factors that increase the risk of surgical fires on or near a patient. The FDA is also recommending practices to reduce these fires from occurring, including the safe use of medical devices and products commonly used during surgical procedures.

Summary of Problem and Scope: Although surgical fires are preventable, the FDA continues to receive reports about these events. Surgical fires can result in patient burns and other serious injuries, disfigurement, and death. Deaths are less common and are typically associated with fires occurring in a patient's airway.

While studying civil engineering at NJIT, I was able to work for the Port Authority of NY & NJ, which granted me the unique experience to work on Freedom Tower, Ground Zero, Port Newark, and Newark Airport.



After graduation, I started as a Project Engineer for Simpson and Brown, Inc., a Marine and Land Construction company, where I performed engineering and project management there for 2 years. The company thought that I was the best fit to start their safety culture and program from scratch. At this point, I had had no safety experience, other than receiving my OSHA 30 in college. I had to learn everything for myself while creating a safety program for a \$130,000,000 annual sales construction company and reached out for help.

During that search, I came across many safety affiliates and joined a few to learn from subject matter experts. The most helpful was American Society of Safety Professionals. From the PDC conferences, safety meetings, webinars, and networking, I was able to learn so much from safety professionals in disparate fields.

That knowledge enabled me to lower incidents, reduce Simpson and Brown's EMR to .232, write a safety manual, establish a safe working culture, and provide positive feedback to everyone in the company in 5 years' time.

After my time at Simpson and Brown, I moved onto my next challenge and created a safety culture and program from scratch for mechanical contractor, Binsky. In a years' time, I was able to establish a return to work policy, lower EMR 80%, and create a safety program where each project goes through a rigorous process starting from the initial bid; all the way to project review to find lessons learned and corrective actions. This process also contains a proactive approach to help improve efficiency and making safety an integral part of each aspect through a project.

I am currently working for PSE&G as a Safety Coordinator for DP&C, and work with both contractors and employees to help create a safer culture in a highly hazardous environment.

I would not be able to get to this point in my career without the help of ASSP; therefore, it is only right to give back to illustrate my gratitude and appreciation to all of those that have helped me in my career path. I look forward to helping the New Jersey chapter continue its Platinum status while looking for ways to help improve on an incredible foundation set forth by those before me.

OSHA Proposes Rule on Crane Operator Certification

After eight years in development, the new rule would remove certification-by-capacity restrictions. Jack Fearing, CPEA – Fearing International Group LLC

Eight years after it began the process of finalizing a rule to govern the certification of crane and derrick operators in the construction industry, the Occupational Safety and Health Administration (OSHA) has finally issued a notice of proposed rulemaking that could just possibly be adopted as a final-final—they really mean it—final rule in 2019.

In August 2010 OSHA issued the final cranes and derricks in construction standard, that called for crane operators to be either certified or qualified, depending on the option elected by an employer, by November 2014. However, in February 2014, the agency proposed another three-year extension to

the operator certification deadline and requested public comment. That deadline eventually was delayed again until November 2017.

Last November, the agency issued its "final" standard, which asserted OSHA's long-held position that an operator is qualified to operate a particular piece of equipment only if the operator is certified for that type and capacity of equipment, or is certified for higher-capacity equipment of that same type. For example, an operator certified to operate a 100-ton hydraulic crane also would be able to operate a 50-ton hydraulic crane—but not a 200-ton hydraulic crane.

Over the years this interpretation created significant concern for many industry representatives, including employers and unions, and firms that offer crane operator training, notes Tressi L. Cordaro, an attorney with the law firm of Jackson Lewis. OSHA now proposes to eliminate any requirement that operator certification be based on the capacity of the crane.

OSHA also stressed that it is unaware of any direct evidence establishing a safety benefit for requiring certification by capacity, and that employee certification by capacity of crane should merely be an option for those employers who wish to use it.

The new proposed rule also seeks to clarify and permanently extend an employer's ongoing duty to evaluate potential operators in regard to their ability to safely operate assigned equipment covered and to require that employers document the evaluation.

Not everyone is happy about this portion of the proposed rule. "Some have become concerned in particular at the implications of the employer evaluation portion of the proposed rule, a new section developed by OSHA to address industry concerns that certification, though valuable, is insufficient by itself to ensure an operator is qualified," observes the National Commission for the Certification of Crane Operators.

"The standard would make certification akin to a driver's learner permit requiring employers to still evaluate an operator's skill and competency to operate equipment safely," according to Cordaro. "The proposed standard is written in performance-oriented language and does not establish what specific skills must be assessed. As drafted, it is possible this requirement to evaluate an operator could change from job to job."

OSHA explained that the proposed standard would "also require employers to evaluate the operator's judgement," not just his or her skills. This means that the employer would have to assess not only the operator's ability to apply knowledge and skills to the everyday requirements of the job, but also the operator's "ability to recognize risky or unusual conditions."

Of course, even the request for comments accompanying release of the latest rulemaking proceeding could not pass without experiencing yet another delay. On June 19, OSHA announced that it extended the period for public comments on its rule proposal from the originally announced deadline of June 20 to July 5.

Proposed SNUR for Asbestos

EPA is proposing a significant new use rule (SNUR) for certain uses of asbestos (including asbestos-containing goods) that would require manufacturers and importers to receive EPA approval before starting or resuming manufacturing, and importing or processing of asbestos. This review process would provide EPA with the opportunity to evaluate the intended use of asbestos and, when necessary, take action to prohibit or limit the use. In the absence of this proposed rule, the importing or processing of asbestos (including as part of an article) for the significant new uses proposed in this rule may begin at any time, without prior notice to EPA.


